#### Expenditure

There are two types of expenditure. Firstly, we have the costs of running the events and the administration costs of running the charity These came to a total of £7,151.77. A breakdown of these is in the table below. Fireworks night was our biggest costing event and this year due to Covid we paid for two sets of defibrillator pads which was more than budgeted. Our Parentkind membership covers our insurance to run events. Other BSA admin costs included, new walkie talkies for firework night as requested from the risk assessment on health and safety at £134.99.

We spent £7,000 on support the school with the library revamp, funding all the corridor bookshelves outside the classrooms. We bought tepees for forest school.

Some of the items funded with each year group included Christmas & Easter gifts, workshops on the Mayans, Egyptians, Florence Nightingale, Victorians, and Great Fire of London. Business week deposits, games, ingredients for food technology and resources for design technology.

#### Academic Year 2023/24

The BSA has a healthy opening balance for AY2023/24 of £13,062.68. Our annual commitments are around £11,000 each academic year, and with the events planned are in a strong position to meet these commitments with a contingency of £1,000 always in the accounts.
